

CLAIM FORM

The records of Niantic, Inc. (“Niantic”) show that you had a valid ticket for, and are believed to have attended, the Pokémon GO Fest in Chicago, Illinois on July 22, 2017. Under the terms of this Settlement, you may be entitled to receive compensation for certain travel and lodging expenses you may have incurred in connection with your attendance at the Pokémon GO Fest.

Please provide only information that is truthful, to the best of your knowledge, in your Claim Form. You are legally prohibited from knowingly providing false information

COMPENSATION

You may be entitled to receive compensation for the various categories of expenses listed below that are applicable to you, subject to any adjustments as set forth in the Settlement Agreement. Please fill in all blanks that apply to you. You may only seek reimbursement of expenses that you incurred to attend the Pokémon GO Fest. You may be awarded the full amount of your claimed expenses or a portion of the full amount in the discretion of the Settlement Administrator and depending on the total amount of valid expenses sought in all of the claims submitted by Settlement Class Members.

If you claim damages that fit within the Airfare Expenses, Hotel/Lodging Expenses, or Car Rental Expenses categories, then you must submit supporting documentation along with your Claim Form that shows you paid the amount you claim.

If you incurred expenses in an amount *less* than the Unverified Expenses Cap set forth for the Parking Expenses, Third-Party Transportation Expenses, Mileage/Gas Expenses, or Toll Expenses categories, you do not have to submit any documents to support your claimed expenses for that category. However, if you believe you incurred expenses *greater* than the Unverified Expenses Cap as set forth for each category, then you *must* submit supporting documentation with this Claim Form to the Settlement Administrator. Missing documentation or insufficient support may affect the amount that you may be able to recover.

Category 1 — Airfare Expenses:

The Settlement provides that if you paid for airfare to travel to and/or from the Pokémon GO Fest, you may be reimbursed partially or fully for the cost of the airfare.

The Settlement provides that you must submit supporting documentation showing your Airfare Expenses along with this Claim Form to the Settlement Administrator.

Category 2 — Hotel/Lodging Expenses:

The Settlement provides that you may be reimbursed partially or fully for up to two (2) nights of a hotel or other lodging in connection with your attendance at the Pokémon GO Fest.

Did you pay for a hotel or other lodging in or near Chicago, Illinois in connection with your attendance at the Pokémon GO Fest?

Category 3 — Parking Expenses:

If you paid for parking for a personal vehicle or rental car in Chicago, Illinois in connection with your attendance at the Pokémon GO Fest, the Settlement provides that you may be reimbursed partially or fully for up to two (2) days of the cost of parking. **Note:** If you stayed in a hotel or other lodging and the cost of parking was included in the amount listed in Category 2—Hotel/Lodging Expenses, do *not* include parking expenses below.

Did you pay for parking for a personal vehicle or rental car in Chicago, Illinois in connection with your attendance at the Pokémon GO Fest?

The Settlement provides that the Unverified Expenses Cap per Settlement Class Member for this category is \$35 per day (for up to 2 days) without providing supporting documentation. However, if you believe you incurred Parking Expenses *greater* than the Unverified Expenses Cap, then you must submit documentation to support your Parking Expenses along with this Claim Form to the Settlement Administrator.

Category 4 — Car Rental Expenses:

If you rented a vehicle in connection with your attendance at the Pokémon GO Fest, the Settlement provides that you may be reimbursed partially or fully for up to two (2) days of the cost of the car rental.

Did you pay for a rental car in connection with your attendance at the Pokémon GO Fest?

Category 5 — Third-Party Transportation Expenses:

If you paid for third-party transportation (*e.g.*, train, taxi, Uber, bus, etc.) to travel to and/or from the Pokémon GO Fest, the Settlement provides that you may be reimbursed partially or fully for the cost of the third-party transportation.

Did you pay for third-party transportation to travel to and/or from the Pokémon GO Fest?

The Settlement provides that the Unverified Expenses Cap per Settlement Class Member for Third-Party Transportation Expenses is \$30 each way (for a total of \$60 round trip) without providing supporting documentation. However, if you believe you incurred Third-Party Transportation Expenses *greater* than the Unverified Expenses Cap, then you must submit documentation to support your Third-Party Transportation Expenses along with this Claim Form to the Settlement Administrator.

Category 6 — Mileage/Gas Expenses:

If you drove a personal vehicle to travel to and/or from the Pokémon GO Fest, the Settlement provides that you may be reimbursed partially or fully for Mileage/Gas Expenses at the rate of 53.5¢ per mile, which is the 2017 Standard Mileage Rate published by the Internal Revenue Service that covers gas and other costs of operating a vehicle.

Did you drive a personal vehicle to travel to and/or from the Pokémon GO Fest?

The Settlement provides that the Unverified Expenses Cap per Settlement Class Member for this category is \$107 (up to 200 miles round trip) without providing supporting documentation. However, if you believe you incurred Mileage/Gas Expenses *greater* than the Unverified Expenses Cap, then you must submit documentation to support your Mileage/Gas Expenses along with this Claim Form to the Settlement Administrator.

Category 7 — Toll Expenses:

If you drove a personal vehicle or rental car to travel to and/or from the Pokémon GO Fest, the Settlement provides that you may be reimbursed partially or fully for the cost of highway tolls.
